USGA RULES GOVERN ALL PLAY
EXCEPT WHERE MODIFIED BY LOCAL RULES



- **DESERT RULE:** If a ball comes to rest in the desert, it may be played as a red penalty area. The player may drop a ball, within two club-lengths of the nearest point of grass relief, from the point the ball last crossed the margin of the penalty area, and no nearer to the hole, with a one-stroke penalty.
- Out of bounds is defined by boundary fences, outside edges of roads, and lot lines.
- Sprinkler heads within two club-lengths of the putting green; Relief may be taken if and only if the ball lies within two club-lengths of the obstruction and interferes with line of play.
- **ABNORMAL GROUND CONDITIONS (Rule 16-1):** Nearest point of relief may be taken if the ball comes to rest on the edge of the turf (lip) that defines the desert, and either interferes with lie, stance, or intended swing. Also, under this rule nearest point of relief may be taken if a ball comes to rest within any defined flower bed that is located inside of the cart path bordering each hole.
